- (a) In case validity of the BIS licenses expires, you are required to submit copy of renewed license within two months grace period failing which the registration shall be cancelled automatically.
- (b) You are required to send the initial available stock & monthly statement of Drip / Sprinkler material supplied to each Authorized Agent / Dealer, to the Deputy Director of Agri. (Ext.) / Asstt. Director Horticulture of the concerned district. It should be ensured that the cases of financing through subsidy are correlated with the stocks available with each agent / dealer.
- (c) You are required to execute an agreement on Rs.500/- stamp for due performance of obligation as per terms & conditions within 15 days if not submitted previously, failing which the registration may be liable for cancellation automatically.
