The Registration of Drip /Sprinkler manufacturers whose registration was cancelled vide Office Order No.105-280, 281-356, 357-532 & 533-708 dated 01.05.2018 is hereby renewed for Drip / Sprinkler Irrigation Programme for Year 2018-19 in Pradhan Mantri Krishi Sinchai Yojna (PMKSY) Scheme under Micro Irrigation in compliance to the interim stay orders passed by the Hon'ble High Court Rajasthan. The list of the manufacturers is attached herewith. The validity of registration is subject to the final judgement by the Hon'ble High Court. This renewal is in accordance with the terms and conditions of the Department and on fulfilling the requisite parameters as per BIS norms / license and its validity. The subsidy would be payable on the approved brand of the registered manufacturer only if the Drip / Sprinkler system is supplied through the manufacturer or his authorized agents. In case of any complaints regarding sub-standard / defective supplies, the Directorate of Horticulture must be immediately informed with full details of the case, so that necessary action can be taken against the defaulter.

Director Horticulture of the concerned district. It should be ensured that the cases of financing through subsidy are correlated with the stocks available with each agent / dealer.
